







IARC is currently undergoing a period of transformation that is likely to position it as the world leader in cancer research. The emphasis is on the principle of open science and true collaboration, providing IARC with the means to achieve its goal of reducing the burden of and suffering from cancer, now and for future generations.

YOU CANNOT SUBMIT an EoI in the following cases:



Any association or relationship with the tobacco or alcohol industry



Any association or relationship with the arms industry



You have or have had recourse to child labour



You are or have been involved in acts of corruption or terrorism

- i) The Contractor agrees that breach of these provisions is a breach of an essential term of the Contract.
- ii) These provisions include the UN's blacklist of debarred or suspended suppliers.
- iii) IARC reserves the right to refuse an offer made by a company that does not meet its criteria.
